Executive Summary

As we presented at the budget study session, we are trying to achieve three things in this budget

Implement the Strategic Plan	 Pre-pandemic our core academic programming was not effective enough We outlined a significant amount of changes to make in our strategic plan
Recruit and Retain Highly Effective Team Members	 Our staff make significantly less than surrounding communities; we need to address compensation while strengthening teacher performance systems, evaluation, and developing a plan to celebrate high-performers This needs to be done sustainably through reducing costs and bringing in new revenue through leases We look forward to discussing this with RTA and CSEA this summer
Respond to the Pandemic	 Coming out of the pandemic we need to accelerate learning and find new ways to support our students We need to do this in a way that maximizes short term impact but is long term sustainable



Executive Summary Tactically, this budget navigates towards those broader aims

- We make significant investments (\$5m+), increasing our overall perpupil expenditure to the highest in Ravenswood history through increases in stimulus funds, REF, and hold-harmless state revenue (LCFF)
- At the same time, we make **targeted reductions across schools and the district office** (\$2m+)
- At the same time, we are able to re-organize our spending to **set aside additional funding for future years**, to make sure that our expenditures glide down slowly over time, instead of quickly crashing
- We are also releasing an unprecedented amount of budget detail in the appendices in this document and on our new interactive budget website

Revenue

While we have high revenue per student, there are looming challenges

Revenue Challenges

- Based on our enrollment declines, we can expect a \$4-5m fiscal cliff coming in SY22-23
- We are targeting spending \$4-5m in stimulus funds over the next few years which will phase out

This represents a 20% drop in revenue

<u>REF</u>

 REF has grown significantly; we are expecting over \$6m in donations from REF this year, compared to \$3m in the recent past

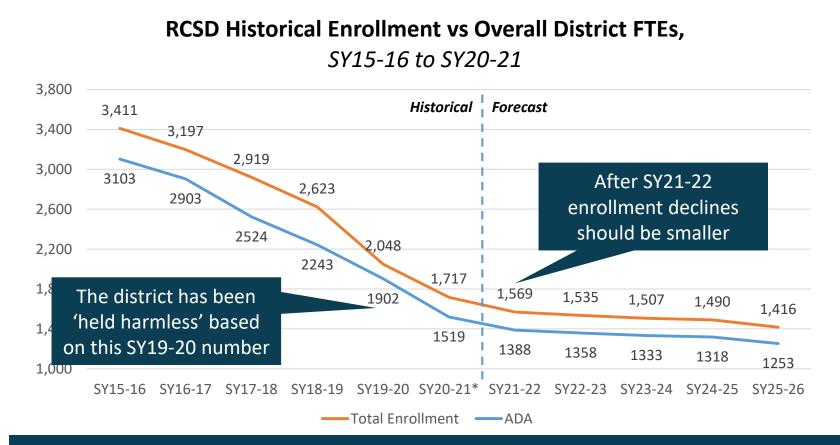
Revenue Opportunities

- The district dipped into basic aid in SY20-21; declining enrollment and rising property taxes may create a floor
- Leasing 2120 Euclid and the Flood Site would create large and reliable revenue streams for the district
- Greater state- and county-wide emphasis on funding equity

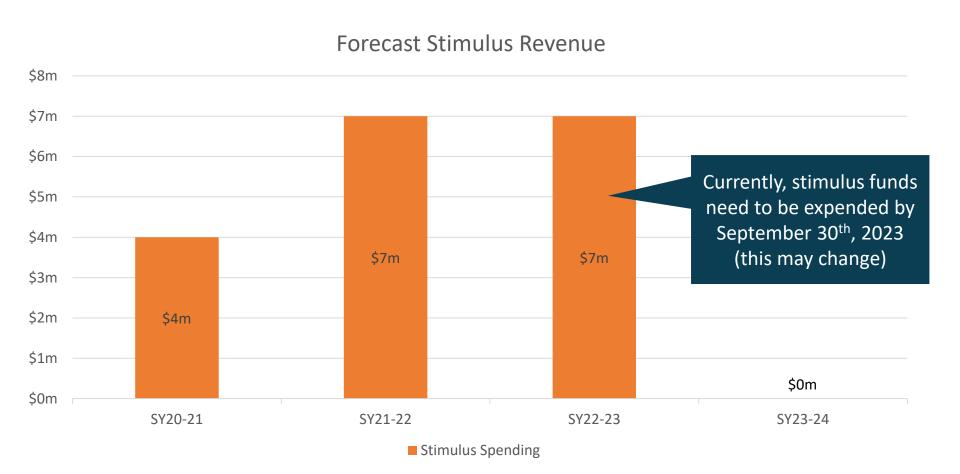
This budget effectively holds us harmless for two years of enrollment declines; creating a \$4-5m LCFF cliff in SY22-23



This is important because our LCFF Allocation is determined by the ADA times by the LCFF per-student allocation. Essentially, in a normal year, this would mean a 20% decrease in LCFF funds....

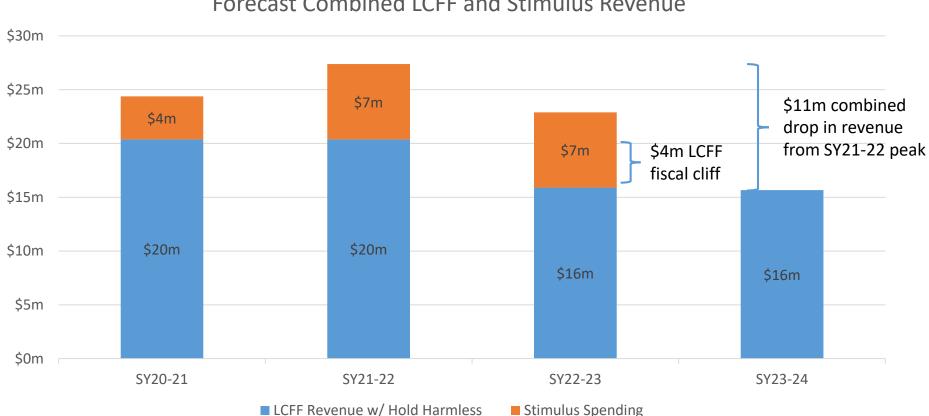
Revenue Stimulus funds are similarly expected to phase out over time

In light of this one-time cash infusion and these looming challenges, we are pursuing a number of revenue strategies

- We are taking steps to **bring students back** into the district
- We are actively seeking out new revenue by pursuing competitive leases for our properties –existing leases such Brentwood, Menlo Oaks, 491 O'Connor and new leases such as the Flood Site and 2120 Euclid
- We continue to strengthen our partnership with REF, as well as pursuing outside grants where possible
- We are carefully **monitoring the district's transition into basic aid**

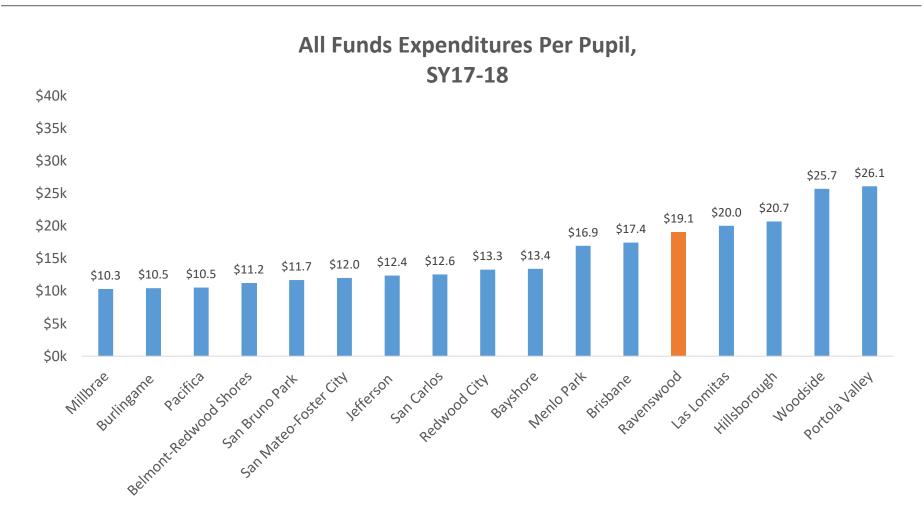

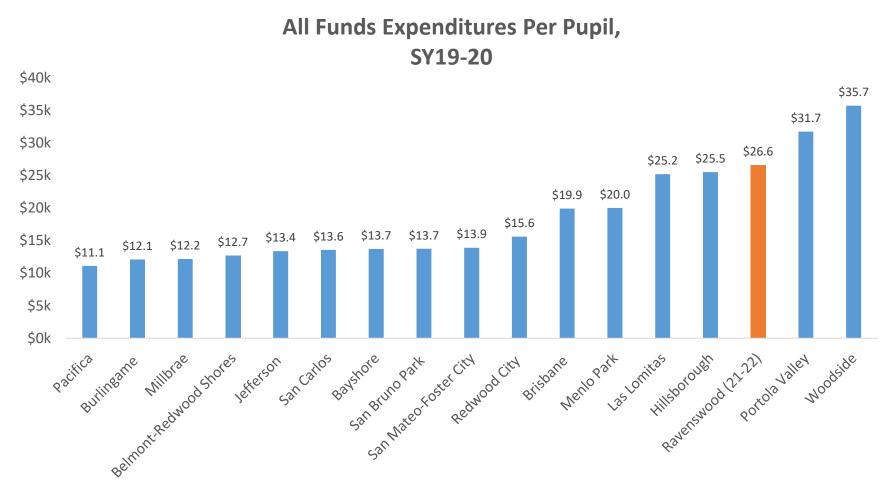
Expenditure Last year we presented a look at RCSD per-pupil spending compared to the county





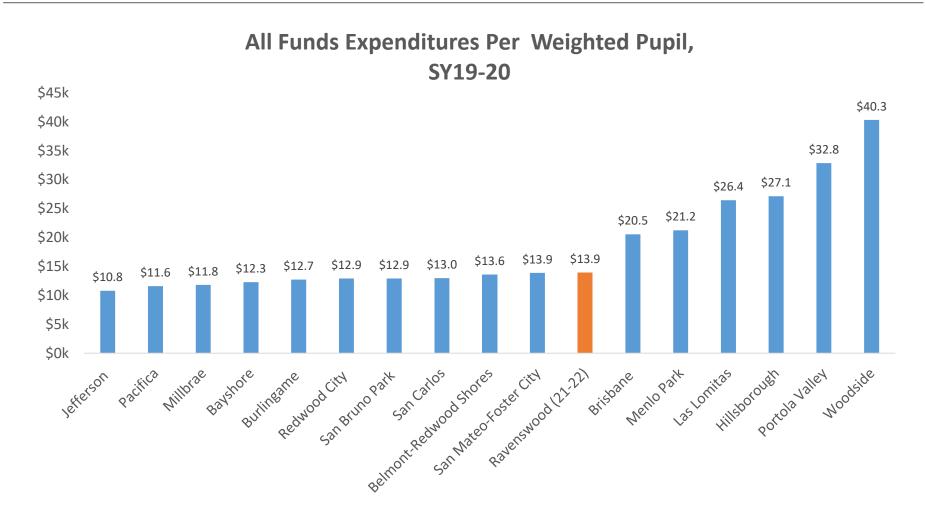

Expenditure Since then, all neighboring districts have seen increases – including RCSD



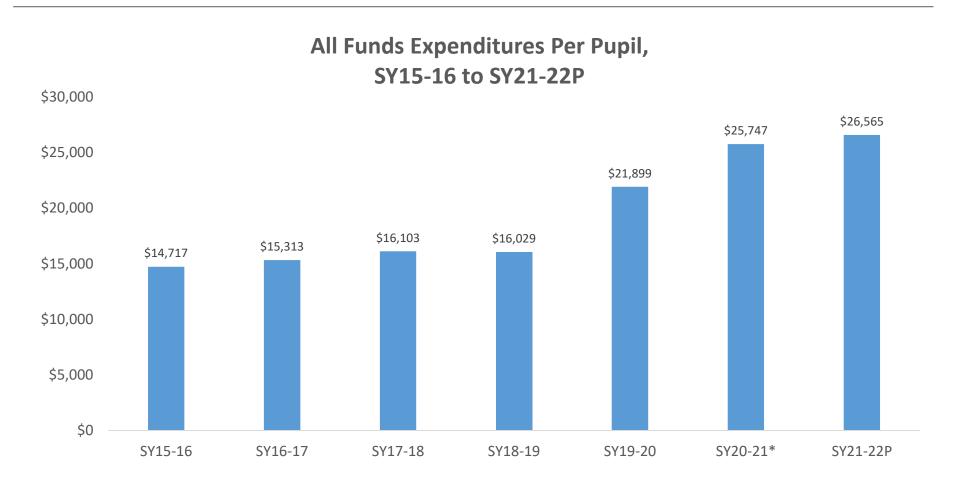


Expenditure However, as before, the picture changes when controlling for need – RCSD is now closer to the county median



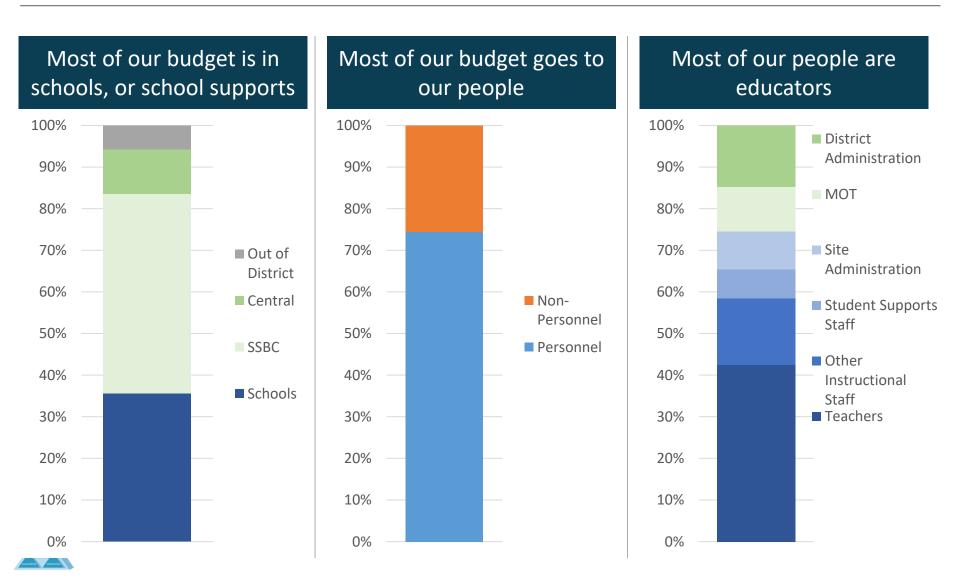


Expenditure In SY21-22 we expect to spend more per student than we ever have as a district

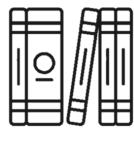

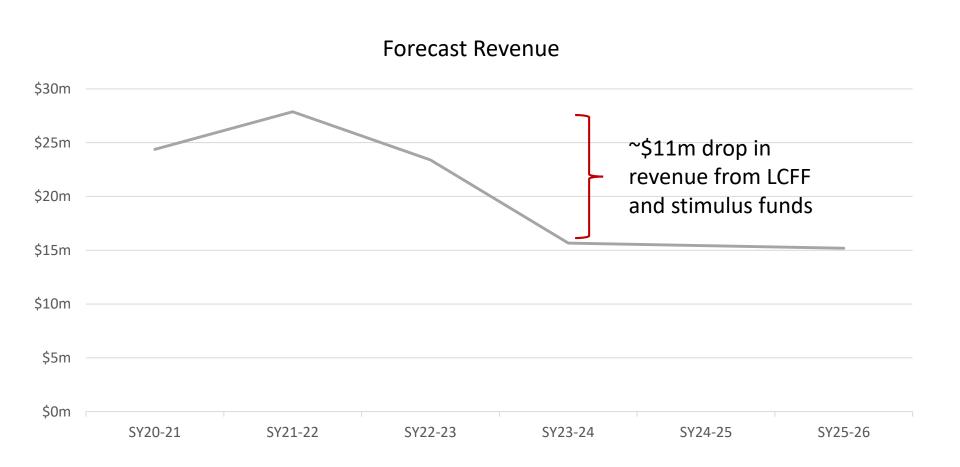

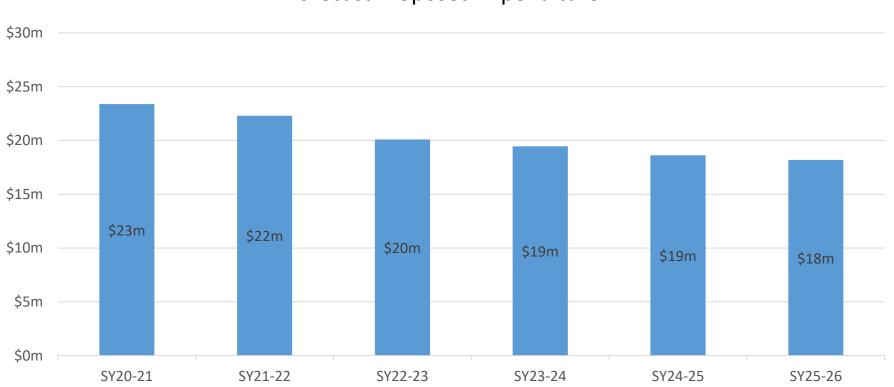
Multi-Year Spending & Saving Plan Given our expected decline in revenue...

Multi-Year Spending & Saving Plan

We estimate that we will need to have saved \$6-10m by SY23-24 in order to smoothly spend down expenditures

- We are hoping that this year we were able to save \$1-3m- we are finalizing some grant movement to confirm this
- In SY21-22 and SY22-23 we are hoping to set-aside an additional \$2.5m, giving us \$6-8m saved between this year and the following two
- We would then use those to slowly ramp down spending over the following school years

We plan on putting the savings to cover anticipated deficits in Fund 17 to make it clear that these are our designated savings.
