School Facility Conditions and Planned Improvements

Belle Haven is in the middle of a two-year building and renovation project. The administrative office and classrooms have been removed from the wings and relocated to portables in the back. The property is so big that the portables do not make the property look or feel crowded. Grass in the back has been removed and paved over. The cafeteria is not being used except to prepare meals. Students eat outside. The cafeteria will be demolished next year and rebuilt. There are nice touches to make the campus feel secure, inviting and cheerful such as: the addition of new play structures, benches placed outside the portables, decorative windows painted by teachers to reflect the theme, "Classic Tales" which they are currently teaching. The backpack holders have been upgraded from metal to plastic which is harder for the students to beak, new fencing has been added to separate the kindergarteners from the older students and additional fencing has been added around the entire property to secure the school. Earthquake putty has been used to secure items on top of shelves and bookcases as recommended last year.

2023-24 School Safety Plan

Our School Safety Plan is reviewed, updated, and approved at the beginning of the year by the SSC/ELAC, and then reviewed and approved by the district's Board. Students are taught the safety procedures outlined in the plan and drills take place to ensure staff and students understand and will act quickly and safely in the event of an emergency.

The plan is designed to be a practical document to be used in case of emergencies, with key elements including the Big Five program which is used by all public agencies in San Mateo County (addressing emergency responses for Shelter in Place; Drop, Cover, and Hold On; Secure Campus; Lockdown/Barricade; and Evacuation), COVID-19 protocols, Behavior policies, Abuse Reporting procedures, Suspension guidelines, and Discrimination and Harassment policies. The Safety Plan also contains a list of emergency telephone numbers, information on the responsibilities of certificated personnel, and details of the warning signals that will alert students and school personnel of disasters that may have occurred. We work closely with and receive assistance from the local East Palo Alto Police Department, Menlo Park Fire Department, and other outside agencies and organizations.

Our district receives funding from LCFF, Title I, Title II, Title III, Title IV, Stimulus funds, and other local funds. This school operates with a "Title I Part A schoolwide program" which means that all students benefit from the programs and services funded with Title I, Part A funds. Some examples include partially funding salaries for LIMS (to support Library Services), CASSY (mental health / counseling services), as well as purchasing supplemental curriculum to support the academic achievement of students.
