The school has dedicated department collaboration time and professional development to ensure that the teachers have the time to evaluate and plan curriculum to have standards rigor. The school is responsible to ensure that the students have the technology to access the online curriculum and the proper materials. The parents are responsible for advocating if their child is missing work, or the technology at home is not working properly.

Student progress reports are formally sent home once each trimester at minimum a month before the grading period is over. Then, the report cards are sent home three times a year. Formal report card conferences are twice per year after the first and second trimesters. We also encourage parents to check their child's work frequently on Infinite Campus. They can check their child's work completion and attendance through the application on their phone. Parents and teachers can email, talk through Parent Square, or on the phone. The school welcomes volunteers and can talk with the Parent Outreach Coordinator to sign up for specific events. The school employees two translators who can ensure parents receive important information in their native language. In addition, there are many bilingual employees to help with communication. This Compact was established by Cesar Chavez Ravenswood Middle School on September 30, 2021, and will be in effect for the 2021-2022 school year. The school will distribute the Compact annually to all parents and family members of students participating in the Title I, Part A program on, or before October 30, 2021.
